9. The State winner will represent her state and attend National Pageant.
10. Entrants must be, and continue to be of good moral character, has not committed crimes resulting in imprisonment, and has not appeared nude or provocative in photographs, films or publications.
11. The State winner will be bound to the rules and regulations as outlined by the Contestant Agreement as provided by The Miss All-Star United States, LLC.
12. Entrants will conduct themselves in a manner that reflects professionalism towards themselves, the State and National Pageant, State Pageant Director, other entrants, and the State prior to, during and throughout her reign as a Local Delegate or State Winner.
